Lipids

- Polyphosphoinositide metabolism in baby-hamster kidney cells infected with herpes simplex virus type 1
Unsaturated fatty acids as endogenous inhibitors of tamoxifen binding to anti-oestrogen-binding sites

Nucleic acids and molecular genetics

- Transcription of genomic bovine and *Xenopus laevis* DNA species by RNA polymerase III in HeLa-cell cytosol extracts
Co-ordinate increase in the expression of Type I and Type III collagen genes in progressive system sclerosis fibroblasts

Synthesis and degradation of macromolecules

- The identification of a major product of the degradation of insulin by 'insulin proteinase' (EC 3.4.22.11)
Control of proteoglycan biosynthesis. Further studies on the effect of serum on cultured bovine articular cartilage
The activation of protein degradation in muscle by Ca^{2+} or muscle injury does not involve a lysosomal mechanism
Inhibition of cell proliferation by interferons. Relative contributions of changes in protein synthesis and breakdown to growth control of human lymphoblastoid cells
